- ⚡ Have a creative style of delivery, and ability to 'wow' young people, taking them on a memorable learning journey. Have a good grasp on popular and youth culture
- ⚡ Have excellent interpersonal skills and ability to build and maintain relationships with teachers, youth within schools, colleges and local authorities.
- ⚡ Be educated to degree level, be a qualified teacher, or have an equivalent level of professional experience. Have a good grasp of Mathematics, having achieved GCSE grade B or equivalent
- ⚡ Have a strong interest in finance and enterprise, and be committed to becoming an expert in these topics. Ideally you will have experience of delivering finance and/or enterprise education, and a good understanding of these curriculum areas
- ⚡ Possess strong IT skills.
- ⚡ Be willing to frequently travel across Liverpool and the North-West area.
- ⚡ Have a fluent command of English and have the right to live and work in the UK
