Financial education became compulsory for state secondary schools in September 2014, yet only 52% of young people aged 7-17 say they have received some form of financial education at school, at home or other settings! Knowing how to make informed choices about money, and understanding the impact of these choices is crucial, because when it goes wrong, the consequences can be devastating.
